WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND PARENTAL CONSENT AND INDEMNITY AGREEMENT

- I do **not** give permission for my child, _____, to leave the HEDGE/Hillside UMC campus at their discretion. Although I do not give permission for my child to leave the HEDGE/Hillside UMC campus, I understand and agree that HEDGE or Hillside UMC will not be held liable if my child chooses to leave campus without my permission.
- I give permission for my child, _____, to leave the HEDGE/Hillside UMC campus at their discretion. I understand the nature and privilege of leaving campus and the maturity level needed from said Minor. I believe the minor to have such experience, maturity level and capability to leave campus. I further agree and warrant and will instruct the minor that if any time the Minor believes the conditions to be unsafe, he/she will immediately discontinue the off campus activity. I will also instruct my child that they are required to sign out of the HEDGE Admin Table prior to leaving and to sign in upon returning.

1. I FULLY UNDERSTAND that (a) leaving the campus of HEDGE/HILLSIDE UMC during any HEDGE function involves risks and dangers, b) these risks and dangers may be caused by the Minor's own actions, or inaction's of others participating in the off-campus privilege or others not associated with THE HEDGE HOMESCHOOL MINISTRY, INC. OR HILLSIDE UMC, or the condition in which the activity takes place or THE NEGLIGENCE OF THE 'RELEASEES' NAMED BELOW; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of the Minor leaving campus

2. I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND TO AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE HEDGE HOMESCHOOL MINISTRY, INC. AND HILLSIDE UNITED METHODIST CHURCH, their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, from all liability, claims, demands, losses, or damages, losses, or damages on the Minor's account caused or alleged to be caused in whole or in part by the negligence of the 'releasees' or otherwise, and further agree that if, despite this release, I, the Minor, or anyone on the Minor's behalf makes a claim against any of the releasees named above, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE, OR COST ANY MAY INCUR AS THE RESULT OF ANY SUCH CLAIM.

I have read this agreement, fully understand it's terms, understand that I and the minor have given up substantial rights by signing it and have signed it freely and without any inducement or assurance or any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by the law and agree that if any portion of this agreement is held to be invalid that the balance, notwithstanding, shall continue in full force and effect.

Please place a check mark in the circle to indicate you have read, understood and agree to comply with each Guideline.

- I agree to wear a HEDGE shirt on Campus at all times, except for Theme Days and other special occasions.
- I agree to check and abide by the published Dress Code Guidelines when HEDGE shirts aren't required.
- I agree to be diligent to clean up my own messes, both indoors and outside.
- I understand that my parents and I will be held responsible for the cost for any HEDGE or Hillside property I damage.
- I agree to speak respectfully to adults, (especially our own parents!), while on Campus.
- I agree to display a cheerful, immediate obedience to authority when given an instruction by a HEDGE teacher or parent.
- I will treat other students with a high level of respect, avoiding unkind comments, hurtful teasing or other forms of mistreatment of others.
- I understand that students not in class must stay in designated common areas. I will not roam the parking lot, building or grounds without permission and/or adult supervision.
- I agree not to use the playground at Hillside without adult supervision (18+).
- I will not invite or bring visitors on campus without prior approval from Admin.
- I agree to avoid situations where I would be alone, behind closed doors or in a car, with a student of the opposite sex who is not related to me.
- I agree that I will not leave Campus for any reason unless my parents have a signed, notarized permission form on file with Admin, and only after I have signed out at the Admin Table.
- I agree to sign in at the Admin Table anytime I have signed out and left Campus, immediately upon my return.
- I agree to conduct my relationships with other students in a way that will be above reproach. I agree not to engage in romantic displays of affection at HEDGE.
- I agree to turn my cell phone and other electronic devices to "vibrate" or "silent" while in class.
- I agree not to read or answer text messages during actual class time.
- I will not cheat.
- I agree to make my personal "best effort" to complete ALL assigned work, turn in my work on time and follow the guidelines set up for each of my classes.

- I agree to keep all my conversations, public or private, positive, constructive and respectful.
- I will diligently avoid the use of foul, dirty or suggestive language, drawings, stories, jokes, pornography of any sort, gossip, misuse of God's name or spiritually meaningful terms, suggestive "sign language", use of degrading names, putting others down by telling them to "shut up" or "get lost".
- I will not bring to Campus or use any form of alcohol, drugs or tobacco.
- I will not bring any form of weapon to HEDGE (except history relics, when that would be appropriate).
- I will participate in service projects and Cleaning Rotation Duty as I am able.
- I will manage my time so that I am not tempted to "skip" one class to study or prepare for another.
- If I am registered for a class, I agree to be in that class if I am on campus.
- I will not engage in any form of inappropriate or disruptive behavior in my classes, including excessive talking or passing notes.
